Warren County Holiday Tidings

About: An exhibition and contest for Representative Peter Beck's 2010 Holiday Card. Subject matter must include scenes and sights of Warren County. Subject matter does not have to be a winter scene.

Opening Reception: Saturday, November 13, 2010 from 4-8 pm

Awards Ceremony: Saturday, November 13, 2010 at 6:00pm

Exhibition Dates: The exhibition and sale will be open and free to the public Saturday, November 13, 2010 through Tuesday, December 7, 2010.

Gallery Location: Gallery 42, 105 E. Main St., Mason, OH 45040

Gallery Hours: Tuesday through Friday, 10-6, Saturday, 11-3.

Eligibility: The exhibition is open to artists 18 years or older. All work must be original in concept, design and execution. Students must not present work for consideration if assisted in any way in arrangement or execution. Artists may be asked for an artist bio for display purposes. All work entered must be two-dimensional. Photography is an acceptable art form for entry.

Entry Procedure Registration and Fees: A *non-refundable* entry fee is required. The entry fee can be dropped off at Gallery 42 or mailed to **MASON-DEERFIELD ARTS ALLIANCE, PO BOX 381, MASON, OH 45040**. Checks should be made payable to: **MASON-DEERFIELD ARTS ALLIANCE**. Entries submitted without payment or received after **November 2** will not be eligible. Deliver your work, with labels attached, to Gallery 42, 105 E. Main St., Mason, OH 45040 according to the time schedule above.

Awards:

1st Place - \$500.00 prize and work will be reproduced as the Holiday Card for Rep. Peter Beck.

Additionally, work will hang in Mr. Beck's State House office.

2nd Place - \$250.00

3rd Place - \$100.00

Two Honorable Mention Awards will be awarded.

Preparation of artwork: Size and weight of work is limited to that which can be moved by one person and no larger than 16" x 20" in size. Only 8"x10", 11"x14", 12"x16" and 16"x 20" format will be accepted. All work must be two-dimensional (size and weight of work is limited to that which can be transported to and from the gallery). Any work that is to be hung must be appropriately framed and wired, and strong enough to support the piece. Museum wrapped canvas is acceptable (please no staples or nails on the edges). The label provided in the entry form must be filled out and affixed to the back of the hanging piece or the bottom of a standing piece.

Entries: An entry fee of \$20.00 entitles you to enter up to 4 (four) pieces into the show.

Schedule: *Deadline:* For delivery of artwork for judging: **Tuesday, November 2, 2010**

Submission of Artwork: All artwork should be dropped off at Gallery 42.

Notice of acceptance: by **Friday, November 5, 2010**.

Pick up of Artwork not accepted: by **Tuesday, November 11, 2010**.

Pick up of Accepted Artwork after show: Artwork should be picked up by **Thursday, December 9, 2010.**
